OFFICIAL RULES

NO PURCHASE NECESSARY

1. PROMOTION DESCRIPTION: The 2023 College Hoops Sweepstakes ("Sweepstakes") begins at 12:00:00 AM (ET) on 1/3/23 and ends at 11:59:59 PM (ET) on 7/31/23 ("Promotion Period"); and consists of three (3) separate entry periods (each, an "Entry Period"), as further described below. - 2. TAKE A PIC of your receipt showing the Qualifying Purchase.
